PRESIDENT'S MESSAGE

I am a first generation auctioneer and have been in the auction industry since 1993, pre online auctions. I absolutely love this industry and when discussing my business platform, I often boast on the fact that I respect tradition and embrace technology. I think you will agree the auction industry has seen dramatic change over the past 10 years, and like it or not, that change continues to evolve.

We know this past year has proved to be quite challenging with some outside influences that have interrupted the way some auctioneers are used to doing business. No matter what side of the fence you're on, we all agreed the auction law needed some updates.

In 2018, a Task Force of thirteen professionals from other industries, as well as the auction industry, was formed to study our current auction law and then the Task Force was asked to make recommendations to "modernize" the current auction law. They did. In the end, the suggested updates to the law were supported overwhelmingly by the House and the Senate and the new law was signed by the Governor in the Spring of 2019.

Just when we thought everyone was in agreement to these updates in our auction law, we were met with a Temporary Restraining Order which was filed on June 28, 2019, just a few days before the new law was to take affect. The State of Tennessee did a good job in responding to the Restraining Order immediately. However, the Judge granted the Injunction, which blocked one of those important new recommended updates regarding "electronic" exchanges. So, now a new challenge has been presented to all licensed auctioneers in the State of Tennessee. The case will be heard in October of 2020.

There are many new updates to our auction law that have made it easier to enter this profession. Some of these updates to the law may seem confusing because some are vastly different from the previous law. At our TAA Winter Convention, we addressed some of these concerns. *Continued on Pg. 2*

NEWEST HALL OF FAME RECIPIENT

On November 17-18, 2019, the Tennessee Auctioneer Association (TAA) held their annual convention in Nashville, a gathering of members and guests alike. On Sunday evening, Auctioneer and TAA Hall of Fame member James Gary presented the newest inductee to the Hall of Fame, Auctioneer David Allen, owner and founder of Nashville-based Music City Auction

I think most people who know David Allen would say it's hard to catch him off guard. However, the Association managed to do just that! As David stated, "I was completely surprised". As the induction ceremony began, he was by his wife Lissa, daughter Cate, (son Jack was unable to attend), and his mother, Grace Allen, which was another surprise. When asked to comment on receiving our industry's most prestigious honor, David, replied he felt "overwhelmed and humbled."

In 1983, David received his college degree in Political Science from Rhodes College in Memphis, TN. After college, he eventually joined his father's business, acquiring décor for the international chain restaurant, TGI Fridays, traveling around the country, buying unique items at antique malls, flea markets and auctions. It was here that David got his first real exposure to live auctions and the auction process. In 2002 he attended the Nashville Auction School. He apprenticed under Auctioneer Wendell Hanson and received his license from the state of Tennessee in 2004. Additionally, he received his firm license and formed Music City Auction. He joined the



state's professional organization, the TAA and served as an at-large member two different terms, as Vice-President, and eventually serving as President of the TAA in 2018.

It was during this period that David became involved in the ongoing efforts to review, examine, and update the auction industry law in Tennessee. He attended regular committee meetings of the Tennessee State legislature, when those meetings were concerned with the auction industry.

In the summer of 2018, he served on the Legislative Task Force, created as a compromise for opposing factions within the auction industry. He ultimately helped craft the legislation that overwhelmingly passed the Tennessee legislature in the spring of 2019 and was signed by the Governor into law. Additionally, David, along with several other Tennessee auctioneers, assisted in the review of current auction questions and the creation of new questions for the state licensing exams for the various auctioneer designations.

So, let's welcome David Allen as our newest inductee into the TAA Hall of Fame.

At our Winter Convention Board of Directors meeting in November, the TAA Board, under the direction of Board Member Eddie Ables of Columbia, voted to roll

out a Scholarship Program as a part of our service to the auctioneering profession and in support of education and youth.

The TAA believes scholarships are an important part of our services to our members. Currently, we are offering one Scholarship for \$500 and our first scholarship will be awarded at our Winter Convention in 2020. The

number of these scholarships will hopefully grow so we can offer multiple opportunities for our youth. Eddie has been working on this initiative for quite some time and we appreciate his efforts.

The scholarship is open to any graduating senior, who is either a child and/or grandchild of a TAA member in good standing, and who plans to enroll in the freshman

class of an institution of higher learning or vocational training institution in any state. The deadline for applications is March 31, 2020. More information will

In addition, Susan Hinson, Vice Chair of the NAA Auxiliary, has announced that the Auxiliary will become a committee under the National Auctioneer Foundation (NAF) in June 2020. The new name will be Legacy Youth Scholarship Committee.

The mission is to provide scholarships to well deserving students and networking opportunity to our supporters and their families. The committee has always given three or more scholarships valued at \$2500. Any child or grandchild of an NAA member will be eligible for the scholarship under this new design. The scholarships are given to a graduating senior or a candidate of a current college, university or school of technology.

TAA CONVENTION A SUCCESS!

The TAA held it's Winter Convention on November 17th and 18th at the Embassy Suites in Nashville and we had a great turnout!

Sunday morning was filled with meetings for the Board of Directors, Foundation, Past Presidents and Hall of Fame. Then, our membership meeting was held on Sunday afternoon. The TAA's lobbyist, Addison Russell, provided a synopsis of the new auction law, the current lawsuit and plans for moving forward. Eddie Ables announced the creation of our new scholarship program, which will, for the first time in the TAA's history, provide financial assistance for higher education goals in the form of a scholarship to qualified applicants. In addition, elections were held. Ritchie Broyles from Morristown and Eddie Ables from Columbia were elected to the Board of Directors. Jay White from Lebanon will be the new Vice President and Patti Baldini of Hendersonville will be the new TAA President.

Drew Williams won the title as Champion and took home 1st place and \$2,500, Tristan Fuller was the runner-up and took home \$1,500 and Jeff Geralds was 2nd runner-up and took home \$1,000.
