Jay Cash showed off his top-flight auction talent recently by finishing second among 39 male competitors at the 2022 National Auctioneers Association International Auctioneer Championship. Cash, who conducts auctions throughout middle Tennessee, has made the finals 3 out of 4 years of competing at the national level placing as high as 3rd in 2018. Cash joined auction professionals from across the world (including TAA Vice President Shane McCarrell who also placed in the Top Ten) on Friday, July 29th, in San Diego, California at the 73rd National Auctioneers Association Conference and Show. Miller took home the top spot, and Iowa's David Whitaker placed 3rd. In the women's division, Chantel Kimball, was named Champion; Yve Rojas, first runner up and Angie Meier, second runner up.



This NAA sponsored program was instrumental in causing this to happen.
